Please read this release in its entirety before signing

I, as the undersigned party, with the full, complete and unrestricted right to enter into a legal agreement, understand and agree without preconditions to abide by the terms stipulated within this release as part of my participation in Voice Of An Angel 2008 ("the Competition").

While no purchase is necessary to participate in the Competition, I understand that participants who are ticket holders for the Florida Marlins Super Saturday Series featuring Jaci Velasquez on Saturday, August 16, 2008 will be guaranteed an opportunity to audition for Producers at the first audition on Saturday, August 16, 2008 at Dolphin Stadium in Miami Gardens, Florida. I have been informed and understand that participants who are not ticket holders for the Florida Marlins Super Saturday Series featuring Jaci Velasquez will be given the opportunity to wait in the standby line for the Saturday, August 16, 2008 Audition at Dolphin Stadium in Miami Gardens, Florida. I understand that if I am chosen for a Call Back Audition at the Saturday, August 16, 2008 Audition, I will be provided one (1) ticket valid for admission to Rock The Universe at Universal Studios on Saturday, September 6, 2008 and must attend the Call Back in order to be eligible to be a contestant for the Competition. I have been informed and understand that paid admission to Rock The Universe 2008 is required for participants who are not selected for a call back to audition for the Contest on Saturday, September 6, 2008 at Rock The Universe at Universal Studios in Orlando, FL. I have been informed and understand that admission for Rock The Universe 2008 is required for my participation in the second audition on Saturday, September 6, 2008 at Rock The Universe at Universal Studios.

I am participating with full knowledge that the audition process or any other portion of the Competition may be altered at the sole discretion of the Organization. I understand that I must meet eligibility based upon the Competition rules and additional criteria as set by Producers. I am a legal resident of the state of Florida. As of the date below, I am not a party to any agreement with a talent agent or manager; a music recording contract (either alone or as a member of a group); I do not have an agreement related to the use of my name, voice and/or likeness; an exclusive acting contract, or any other contractual agreement (written or oral) that, in the Organization's sole discretion, would prohibit me from participating fully in the show and/or entering into any contracts required by the Organization, including an exclusive management contract, recording contract and merchandising contract. I represent and warrant to the Organization that I will not enter into any such agreement(s) during the Competition, without the Organization's prior written consent.

By participating, I grant the Organization and its successors, licensees and assigns, the irrevocable right, but not the obligation, with or without my knowledge, to film, tape and/or photograph, record, exhibit, edit and otherwise use my appearance, name, likeness, voice, singing voice, conversation, sounds and biographical data on or in connection with the Competition in any manner in the Organization's sole election and discretion, which use shall not entitle me to receive any compensation whatsoever. I understand that the Organization is the sole owner of all results and proceeds of such film, tape, photography and/or recording and my appearance thereon, with the right for the Organization and its successors, assigns, and licensees, forever and throughout the universe, to use the same and any portion thereof in any and all media, whether now known or hereafter devised, including, without limitation, motion pictures, television and publishing, and in connection with the advertising, sale, promotion, marketing, merchandising, distribution, publicizing and all other types of exploitation of the Competition or any part thereof, or in any manner whatsoever. I agree that my participation in the Competition, if any, shall not be deemed to be a performance and is not employment under any

collective bargaining agreement or performing arts guild (including but not limited to AFTRA and SAG) and does not entitle me to wages, salary, residuals, corporate or other benefits or other compensation under any such collective bargaining agreement or otherwise. I will not disclose or discuss events related to the Competition, or authorize any third party to do the same, without the prior written approval of the Organization and Production Staff. I shall not directly or indirectly issue or permit the issuance of any publicity whatsoever with respect to the Competition or my participation in connection therewith. I shall not use the name of the Competition in any way at any time without the Organization's prior written approval in each instance.

By participating, I waive any and all claims of liability against the Organization, its employees and agents, the Florida Marlins, Dolphin Stadium, Universal Orlando® Resort, the Competition's sponsors and their respective employees and agents for any personal injury or loss that may occur from the conduct of, or participation in the Competition. In the event that I perform or display any original material as part of my participation in the Competition written or otherwise controlled by me (for example, music, choreography, photography, lyrics, clothing, etc., collectively called the "Material"), I grant to the Organization, without charge, the rights necessary to perform and/or display the material and the rights required to exploit the Competition and the ancillary rights therein, inclusive of the Material, in any and all media now known or hereafter devised, and for any other purpose, throughout the universe in perpetuity. By participating I acknowledge that there is a possibility that after my execution of this Release Form, I will discover facts or incur or suffer claims which were unknown or unsuspected at the time the Release Form was executed and which, if known by me at that time, may have materially affected my decision to execute the Release. By participating I assume any such risk of such unknown facts and such unknown and undisputed claims.

I agree to be bound by the decisions of the Producers. I understand that decisions made during but not limited to the audition and contestant selection process are final and the interests of the Competition shall override those of any Participant. I understand that my selection to Audition is within the Organization's sole discretion and the Organization is not obligated to grant me an audition. I understand that the Organization reserves the right to disqualify me at any time and may refuse to award any prize to me based on inability to meet eligibility standards, the violation of any rule, the gaining of an unfair advantage, the obtaining of winner status by fraudulent means, or for any reason or no reason at all. I understand that the Organization is not obligated to have me appear on, or have my appearance broadcast during the Competition. I understand that I may not give or agree to give anything of value to any member of the Production Staff, anyone associated in any manner with the Organization, or any representative of any media outlet for the Organization's undertakings hereunder.
